HGPI IS COMMITTED TO PURSUING THE CREATION OF A BETTER WORLD

Health and Global Policy Institute (HPGI) is proud to be independent, non-profit, and non-partisan, which is rare among think tanks in Japan.

When HGPI develops policy recommendations, we do not base them on the opinions of any single specific expert or sector, but develop them through true multistakeholder discussion that brings together people from industry, government, academia, and civil society. We gather diverse opinions and synthesize them in policy proposals.

It is now more important than ever that healthcare policy be created based on the collective knowledge of society. In order to achieve that, it is crucial that we approach policy development via a process of rigorous debate in which representatives of industry, government, academia, and civil society can participate as equals. Fair discussions that are open to people from all relevant sectors are especially important for policy topics in the fields of health and healthcare, as these fields impact the lives of every single member of the public. Unfortunately, opportunities to synthesize collective knowledge in this manner are still too few in Japan.

Multistakeholder-developed, broad-based policy proposals are more impactful and useful than policy proposals that represent the views of only one specific industry or stakeholder. We believe that it is our commitment to the development of such proposals that has allowed us to influence policy reforms up to this point.

Based on that belief, we have focused our activities in recent years around a singular policy: "HGPI is dedicated to fostering multi-stakeholder health policy debate globally, with a commitment to the inclusion of civil society. Through conversations with stakeholders, HGPI is working to realize evidence-based health policies that are meaningful in a global context, and of real value to the people that need them the most."

What is the best way to gather diverse opinions and synthesize collective knowledge? We want to create evidence-based policy proposals, but how should we define "evidence" in our recommendations, when health policy so often focuses on such broad topics as the way people live, their happiness, and their health? Policy creation and validation sometimes requires us to redefine existing values and methods. This requirement should not be taken lightly. We believe that we must approach the development of health policy seriously, with an understanding of the true impact that policy can have on people's lives. I believe that our serious approach to these issues is what makes it possible for us to consistently gather diverse stakeholders from all sectors for open and free debate on various policies.

Every one of the core members of HGPI is committed to pursuing the creation of a better world. We are dedicated to developing the policy options that society needs through careful and deliberate debate. We humbly request your continued support for these efforts.



MAY 29, 2025 Policy Recommendations

Recommendation for the Basic Policy on Economic and Fiscal Management and Reform 2025: Toward Promoting Measures Against Antimicrobial Resistance (AMR)

AMR Alliance Japan released "Recommendation for the Basic Policy on Economic and Fiscal Management and Reform 2025" to promote infectious disease control measures combat antimicrobial resistance (AMR).

- · In AMR control, discuss and advance efforts to secure or conduct R&D on antimicrobials by reviewing or expanding market incentives with multi-stakeholder engagement involving industry, government, academia, and civil society and serve the international community as a leader while balancing national and global interests.
- In addition, Japan should reinforce production systems, stabilize supply chains, and take similar measures to secure ingredients for antimicrobials and diagnostic reagents as medical countermeasures (MCMs) as a priority issue for economic security.
- · While harmonizing with efforts to advance healthcare digital transformation (DX), promote infectious disease control based on the One Health approach by gathering accurate epidemiological surveillance data and expanding systems for rapid analysis.

Policy Recommendations

Ensuring Equitable Access to Cancer Gene Panel Testing and Key Considerations for Applying the Mixed Medical Services Program



This recommendation addresses institutional issues in Japan's cancer genomic medicine system, where cancer gene panel testing (CGP) is, in principle, limited to patients who have completed standard treatments. As a result, optimal treatment opportunities are sometimes missed, creating disparities in access among patients. Furthermore, ongoing discussions regarding the application of Japan's Mixed Medical Services Program—a regulatory framework allowing partial integration of insured and uninsured treatments—raise additional concerns about equity and sustainability.

Perspective

- Abolish the current restriction that limits CGP to patients who have completed (or are expected to complete) standard treatment under the national reimbursement system. Testing should be made available at an appropriate time in accordance with relevant clinical guidelines, enabling patients to receive the right treatment at the right time.
 - When considering the application of CGP from the initial treatment phase under the Mixed Medical Services Program, the discussion must recognize that CGP is already being used to select approved standard therapies and that significant socioeconomic disparities exist in private insurance coverage. Public coverage should remain the foundational goal.
- As a transitional measure, Japan should promote the development of cross-drug companion diagnostics.

 Simultaneously, policymakers should continue to address the systemic divide between CGP and companion diagnostics under the reimbursement structure and prepare for future integration with whole genome sequencing.

Mental Health





MAY 23, 2025 Japan-Australia Online Round Table Discussion

The Impact of Social Media on the Mental Health of Children and Young People and How Social Media Should Be Used in Society

This roundtable discourse convened knowledgeable representatives with different perspectives and from different backgrounds, including the young people in question, researchers and policy makers from Japan and Australia. The discussion was based on the latest policy and research trends, scientific evidence and practical knowledge from a cross-sectoral perspective, with reference to the Australian approach.



Activities towards the 4th UN High-Level Meeting (HLM4) on Non-Communicable Diseases (NCDs) and Mental Health (Scheduled for September 25, 2025)

MAY 02, 2025 HGPI participated in the Multi-Stakeholder Hearing held at the United Nations Headquarters in New York. The event aimed to gather perspectives from civil society, patients and people living with NCDs, youth, the private sector, international organizations, and governments in preparation for HLM4.

MAY 23, 2025 At the request of the President of the UN General Assembly, the co-facilitators—the Permanent Representatives of Saint Vincent and the Grenadines and Luxembourg—circulated the Zero Draft Political Declaration ahead of the HLM4. In response to this international process, HGPI submitted joint inputs from its Planetary Health, Antimicrobial Resistance (AMR), and Global Health Strategy Projects. These recommendations also reflect insights developed through long-standing work on individual NCD-related areas such as dementia, mental health, kidney disease, obesity, cardiovascular disease, and cancer.

MAY 27, 2025 HGPI released an urgent recommendations for HLM4: "Addressing Commercial Determinants of Health through Regulation of Alcoholic Beverage Availability."

Reshaping Japan's Immunization Policy for Life Course Coverage and Vaccine Equity: Challenges and Prospects for an Era of Prevention and Health Promotion

These recommendations revisit the fundamental principle of Japan's immunization and vaccination programs, to prevent vaccine preventable diseases (VPD), and outline the long-term direction for future immunization and vaccine policy in Japan.

Discussion Point

- Conditions for vaccines to be included in the routine immunization schedule must be clarified and the positioning of category B and related diseases in the Immunization Act must be reviewed
 - The national government and local governments must unite in expanding immunization financing to correct disparities in immunization opportunities among municipalities or by area of residence.
- Correcting age-based disparities in immunization opportunities will ultimately require a full redesign of the immunization system that takes precedents set by local governments into account.
 - Revaccination support and similar measures must be expanded to address disparities in immunization opportunities caused by disease risk.
- The functions of the Immunization and Vaccine Subcommittee and similar groups must be reinforced, and the immunization system must undergo evidence-based evaluation.
 - Policy discussions must be advanced through multi-stakeholder discussions that consider immunization policy in terms of the overall health system.



Japan's Healthcare Costs and the Sustainability of Universal Health Coverage

This session featured a discussion with the participants led by HGPI's board member Dr. Yusuke Tsugawa and Senior Associate Mr. Kai Shigeno. Following a presentation by Dr. Tsugawa on Japan's healthcare cost challenges from a health economics perspective, a wide range of opinions were exchanged from the participants. Topics included the evaluation criteria needed for future healthcare, the definition and listing process for low-value care, the overutilization of medical resources occurring in clinical settings and intervention methods; approaches to long-term care costs, the nature of evidence in preventive medicine; the relationship between wasteful medical care and personalized medicine, the acceptable scope of healthcare cost reduction, and the fundamental question of whether healthcare cost reduction is truly necessary.

The Planetary Health Project at HGPI has released a policy recommendation titled "Institutional Design for Responding to Health Crises in the Era of Climate Change — Integrating Preparedness for Both Upstream and Downstream Impacts of 'Disaster-Level Heat' into the Basic Policy on Economic and Fiscal Management and Reform (2025)", also known as the Honebuto Policy.

This proposal highlights the urgent need to realign national policy through the lens of Planetary Health from the following three perspectives.

Integrating "Planetary Health" as a Growth Strategy — Proposal for the Grand Design and Action Plan for a New Form of Capitalism (2025 Revised Edition)

The Planetary Health Project at HGPI has released a policy recommendation calling for the integration of a "planetary health" perspective—emphasizing the interconnection between the environment and human health—into the core of the "Grand Design and Action Plan for a New Form of Capitalism (2025 Revised Edition)."

This proposal highlights the importance of adopting planetary health as a cross-cutting policy framework to materialize key goals of the new capitalism, such as creating a virtuous cycle of growth and distribution, fostering new markets through the resolution of social challenges, and improving national well-being. It underscores the need to integrate planetary health into green transformation (GX) strategies, healthcare policy, and disaster resilience planning.

Held under the theme, "Fostering multilateral collaboration among young leaders to address planetary health challenges," the program brought together 12 participants from Japan, Thailand, and the United States over a six-month period. Women's Health Project has published a summary of key discussion points based on the roundtable discussion held on November 19, 2024. In the discussion, participants deliberated on specific measures and policies to promote menopause and women's health measures in the workplace based on the five perspectives HGPI identified through its activities in 2023 as necessary for promoting menopause measures in the workplace: "1. Strengthening Lifelong Mental Health Support for Children with Intellectual Disabilities

Our FY2024 activities aimed to establish a mental health support system for children with intellectual disabilities and to further expand opportunities for the early detection and intervention of mental disorders. As part of these efforts, we developed and carried out a skill development program for promoting mental health for high school students with intellectual disabilities. After implementing the program, we also conducted an effectiveness assessment to gauge its impact. We then compiled policy recommendations that reflect our findings and interviews with specialists and supporters. We aim to broadly disseminate these recommendations to policy makers and other key parties in hopes of creating a future in which children with intellectual disabilities can grow up with peace of mind and live true to themselves as full members of society.

Advocacy Activities to Encourage the Adoption of the Recommendations in Our Policy Proposals



HGPI composes and publishes reports and policy proposals for each of its projects. HGPI also makes efforts to encourage the implementation of the recommendations contained in those publications through advocacy activities targeting the government and Diet. Those efforts include providing explanations on the content of each report and proposal to representatives from relevant departments with the local and national government or to Diet members and local assembly members on an individual basis. In addition to cooperating closely with parties relevant to each project from the local and national government, HGPI also functions as a hub that creates links within the community of experts in each field when creating content for Diet member study sessions or when drafting bills. We engage in these cooperative efforts with a shared intent of encouraging the implementation of concrete policies based on our recommendations. In the past, recommendations included in HGPI's reports and policy proposals have been reflected in policies after having been cited in presentations made by various groups within the government, including nonpartisan Diet member groups and project teams, or in proposals composed by those groups.
