# MESSAGE FROM CHAIR

#### HGPI IS COMMITTED TO PURSUING THE CREATION OF A BETTER WORLD

Health and Global Policy Institute (HPGI) is proud to be independent, non-profit, and non-partisan, which is rare among think tanks in Japan.

When HGPI develops policy recommendations, we do not base them on the opinions of any single specific expert or sector, but develop them through true multistakeholder discussion that brings together people from industry, government, academia, and civil society. We gather diverse opinions and synthesize them in policy proposals.

It is now more important than ever that healthcare policy be created based on the collective knowledge of society. In order to achieve that, it is crucial that we approach policy development via a process of rigorous debate in which representatives of industry, government, academia, and civil society can participate as equals. Fair discussions that are open to people from all relevant sectors are especially important for policy topics in the fields of health and healthcare, as these fields impact the lives of every single member of the public. Unfortunately, opportunities to synthesize collective knowledge in this manner are still too few in Japan.

Multistakeholder-developed, broad-based policy proposals are more impactful and useful than policy proposals that represent the views of only one specific industry or stakeholder. We believe that it is our commitment to the development of such proposals that has allowed us to influence policy reforms up to this point.

Based on that belief, we have focused our activities in recent years around a singular policy: "HGPI is dedicated to fostering multi-stakeholder health policy debate globally, with a commitment to the inclusion of civil society. Through conversations with stakeholders, HGPI is working to realize evidence-based health policies that are meaningful in a global context, and of real value to the people that need them the most."

What is the best way to gather diverse opinions and synthesize collective knowledge? We want to create evidence-based policy proposals, but how should we define "evidence" in our recommendations, when health policy so often focuses on such broad topics as the way people live, their happiness, and their health? Policy creation and validation sometimes requires us to redefine existing values and methods. This requirement should not be taken lightly. We believe that we must approach the development of health policy seriously, with an understanding of the true impact that policy can have on people's lives. I believe that our serious approach to these issues is what makes it possible for us to consistently gather diverse stakeholders from all sectors for open and free debate on various policies.

Every one of the core members of HGPI is committed to pursuing the creation of a better world. We are dedicated to developing the policy options that society needs through careful and deliberate debate. We humbly request your continued support for these efforts.



#### MAR 18, 2025 Advisory Board Meeting

Challenges and Solutions in Ensuring Continuity from Health Checkups to Medical Care from the Perspective of Patients and Those Affected by Chronic Kidney Disease (CKD)

In FY2024, HGPI conducted two surveys based on the patients' perspective and individuals affected by CKD to identify relevant issues: a quantitative survey on behavioral challenges in seeking medical care, and a qualitative survey involving interviews with patients regarding the transition from health checkups to medical care. Based on the findings from these surveys, HGPI organized this Advisory Board meeting on March 18, 2025, convening experts from industry, government, academia, and civil society to discuss challenges and potential solutions related to the continuity of care from checkups to treatment.

#### JAN 21, 2025 Inclusive Community Dialogue on Building an Inclusive Society for People with Dementia

#### **Omuta City, Fukuoka Prefecture**

HGPI held an "Inclusive Community Dialogue" in Omuta City, Fukuoka Prefecture, where local residents, including people with dementia, gathered to discuss the future of an inclusive society. This "Inclusive Community Dialogue" aimed to review past initiatives and their outcomes related to dementia in Omuta City, while envisioning the future of a society in which individuals with lived experience of dementia and residents can live happily and achieve their full potential. Through group work and graphic recording sessions, participants shared their experiences and thoughts about dementia, engaging in dynamic dialogue.



### FEB 04, 2025 Roundtable Discussion to Promote the Participation of People with Dementia, Their Families and Caregivers in Medical Research on Dementia

Promoting the participation of people with dementia, their families and caregivers in research requires a continuous forum for multi-stakeholder discussions to highlight issues and challenges and build consensus. This time, a roundtable discussion was held with multiple stakeholders including people with dementia, families, academia, and industry representatives, with the aim of exchanging opinions for the purpose of establishing an ongoing conferential discourse for the advancement of dementia research.

#### Let's Talk About Research

HGPI hosted a "Round Table Dialogue" as one of the initiatives to promote the involvement of people with dementia and their families in research, as specified in The Basic Act on Dementia to Promote an Inclusive Society. We hosted and collaborated with Dr. Yoshiki Niimi (Project Associate Professor, University of Tokyo Hospital), a notable researcher in the Alzheimer's disease field, and the members of the "Orange Door Mitaka" dementia support group. During the event, Dr. Niimi provided an overview of what research is and the role of medical research in dementia using simple and accessible language based on his personal experiences and research.

Dementia Policies for Our City: Taking the First Step in Promoting Future Measures for Dementia

HGPI prepared these recommendations to provide local government officials with the information they need to develop local plans for the promotion of policies on dementia and to promote dementia measures after those plans are implemented. The recommendations are based on research conducted by HGPI in FY2024 through efforts that included conducting surveys and interviews, and hosting discussions in model regions. For our initial release, we are publishing our first set of recommendations as a preliminary online version. The second set will be presented in summer 2025 and we also plan to distribute a printed version of our recommendations to local governments across Japan.

The Future of Dementia Research Co-created with Affected Parties, Vol. 1: Three Key Points for Achieving Meaningful Involvement



In the field of dementia, there are high expectations for innovative developments that reflect the needs of people with dementia, their families, and their caregivers, and there is a need to foster a research environment that facilitates the involvement of these parties. Many opinions from people with dementia were reflected during the formulation process of the Basic Act on Dementia to Promote an Inclusive Society enacted in 2023, which makes clear mention of the importance of involvement for people with dementia and other affected parties. In this regard, it differs greatly from past measures. As its title suggests, the objective of the Basic Act on Dementia is to create an inclusive society. Article 1 describes the significance of an inclusive society and aims to surpass healthcare and welfare policies to provide a framework for all of society to be inclusive for people with dementia.

## **CIVIL SOCIETY ENGAGEMENT**

#### **Survey on Healthcare in Japan**



To grasp what healthcare the public truly wants and to gauge public awareness and opinions on health policy issues, HGPI has been conducting public opinion polls since 2006. HGPI has been independently selecting the topics and has been conducting surveys on a wide range of domestic and international agendas, including healthcare satisfaction, global health, and vaccine policies.

#### **Research Report**

The 2025 Public Opinion Survey on Healthcare in Japan

In December 2024, HGPI conducted a nationwide public opinion survey of 1,000 men and women age 20 years and over. In addition to examining satisfaction in healthcare like past surveys, this year's survey also asked about access to healthcare institutions and medicines in light of recent developments like work-style reform for physicians and the launch of the system for patient-selected extra medical services. This year's survey also examined public awareness of the use of medical information.

#### **Key survey findings**


Satisfaction in healthcare increased slightly, but was generally the same as previous years

- Almost 70% of respondents expressed satisfaction toward Japan's healthcare and health system overall
- Satisfaction with "access to healthcare institutions" was almost the same as in our 2023 survey, which found that satisfaction decreased after the start of the COVID-19 pandemic



While 60% of respondents supported the secondary use of medical information, many expressed the need to protect private information and to have careful security measures and clear terms of use

- When asked about their use of My Number cards as insurance cards under 50% responded, "I have already started"
- Regarding secondary use of medical information including for research, 60% responded, "I would wholeheartedly support its use" or "Depending on the purpose, I'd be willing to allow its use." When asked about conditions for secondary use, responses included, "When the information is processed in a manner it cannot be used to identify individuals," "When there is a clear purpose for the use of the data," and "When adequate security measures have been put in place"
- Sixty percent of respondents supported the use of medical information (such as from medical records or test results) for research. As for the purposes of such use, respondents had the highest expectations for "the development of new treatments or therapeutics"



#### **HPA: Health Policy Academy**

The 13th Session "Citizenship and Health Policy"



Since its inception in 2015, the program has now reached its 13th term. This year's theme, "Citizenship and Health Policy," was tackled through a comprehensive curriculum, including seven lectures, a special study session, and an interim presentation. Through these activities, participants gained a solid foundation in health policy, covering theoretical, analytical, and practical aspects.

JAN 09, 2025 Lecture 8 Civil Society and Advocacy

Ms. Kyoko Ama, Fellow of HGPI, delivered a lecture on the theme "Civil Society and Advocacy." Drawing from her work focused on the "effective use of pediatric healthcare," a central aspect of her activities, she shared insights into how citizens can engage in policy-making, the processes of building consensus, and essential mindsets for advocacy.

participants presented the policy proposals and implementation processes they had developed through approximately six months of group work. Following these presentations, feedback was provided by Mr. Kohei Onozaki, HGPI Board Member, and Ms. Kyoko Ama, HGPI Fellow. The proposals were the culmination of health policy issues identified through extensive research and group discussions, as well as insights gained from the course lectures. Furthermore, by considering the review process of stakeholders, participants gained a deeper understanding of the processes involved in policy implementation.





#### Health Policy Academy the 14th Session Has Been Officially Scheduled (Starts July 2025)

The 14th term will offer an upgraded curriculum that includes perspectives on more diverse healthcare systems. In addition to the theoretical aspects such as ethics, norms, and the use of evidence that form the basis of policy, we will cover content that looks to the future of health policy, as well as advocacy activities to engage seriously with society from the perspective of individual citizens. 

#### FEB 12, 2025 **Session 1**

#### Improving Productivity through the Streamlining of Healthcare and Long-Term Care Services and the Utilization of ICT

The conversation centered on the critical state of Japan's healthcare system as it confronts aging population and rural depopulation challenges. Participants discussed specific issues including hospitals operating at a deficit, physician shortages in rural areas, and the closure of medical clinics. A range of multifaceted solutions were proposed, such as management reforms for healthcare institutions, task shifting initiatives, technological innovation, and reconsideration of patient financial responsibilities. The discussion also addressed broader challenges, including the difficulty of building national consensus for systemic reforms, the need for mindset changes among healthcare professionals, and questions about the sustainability of Japan's "anyone, anytime, anywhere" free access healthcare principle.

In FY2024, HGPI marked its 20th anniversary, made possible by the unwavering support and endorsement of many stakeholders. On February 1, 2025, HGPI held a special 20th Anniversary Reception Party in conjunction with its flagship event, the Health Policy Summit, which has been held annually since 2006, to express our gratitude to those who have supported our mission.

#### **Health Policy Summit**

**Uniting Global Leaders Across Sectors** 

Two panel discussion sessions were held to address pressing healthcare policy issues that lie at the core of Japan's health system. These sessions brought together leading experts from both Japan and abroad to engage in in-depth discussions on the following themes.

### Demographic Transformation and the Future Structure of the Acute Care Provision System

In-depth discussion was held on the challenges related to the imbalance between healthcare supply and demand, regional disparities in the distribution of physicians and other healthcare professionals, and disparities among medical specialties—all issues related to demographic shifts. The session also explored potential solutions and future outlooks, based primarily on the 2024 findings of the Committee on the New Community Medical Care Vision.

#### The Past and Future of Policymaking: Examining the Feasibility of Evidence-Based, Citizen-Centered Health Policy

Based on a review of the history and evolution of Evidence-Based Policymaking (EBPM), this session held a comprehensive discussion on whether the pursuit of "rational policy decisions" grounded in evidence represents the limits of the representative democracy. Participants explored what the policy making process should be in today's rapidly changing society, both domestically and internationally, and what the future of healthcare policy should look like. The discussion incorporated perspectives from policymaking theory, political philosophy, anthropology, and real-world politics.

#### **Future Prospects**

The Kiyoshi Kurokawa Award aims to spotlight and amplify innovative initiatives from the Asia-Pacific region, sharing these efforts with the global community. By providing a platform for young leaders, HGPI hopes to advance sustainable health policy solutions worldwide while fostering international dialogue. This initiative also seeks to bridge the gap between Japan and the international community, enabling the exchange of best practices, lessons learned, and new ideas to inform both global and domestic healthcare policy.

### Advocacy Activities to Encourage the Adoption of the Recommendations in Our Policy Proposals



HGPI composes and publishes reports and policy proposals for each of its projects. HGPI also makes efforts to encourage the implementation of the recommendations contained in those publications through advocacy activities targeting the government and Diet. Those efforts include providing explanations on the content of each report and proposal to representatives from relevant departments with the local and national government or to Diet members and local assembly members on an individual basis. In addition to cooperating closely with parties relevant to each project from the local and national government, HGPI also functions as a hub that creates links within the community of experts in each field when creating content for Diet member study sessions or when drafting bills. We engage in these cooperative efforts with a shared intent of encouraging the implementation of concrete policies based on our recommendations. In the past, recommendations included in HGPI's reports and policy proposals have been reflected in policies after having been cited in presentations made by various groups within the government, including nonpartisan Diet member groups and project teams, or in proposals composed by those groups.


