MESSAGE FROM CHAIR

HGPI IS COMMITTED TO PURSUING THE CREATION OF A BETTER WORLD

Health and Global Policy Institute (HPGI) is proud to be independent, non-profit, and non-partisan, which is rare among think tanks in Japan.

When HGPI develops policy recommendations, we do not base them on the opinions of any single specific expert or sector, but develop them through true multistakeholder discussion that brings together people from industry, government, academia, and civil society. We gather diverse opinions and synthesize them in policy proposals.

It is now more important than ever that healthcare policy be created based on the collective knowledge of society. In order to achieve that, it is crucial that we approach policy development via a process of rigorous debate in which representatives of industry, government, academia, and civil society can participate as equals. Fair discussions that are open to people from all relevant sectors are especially important for policy topics in the fields of health and healthcare, as these fields impact the lives of every single member of the public. Unfortunately, opportunities to synthesize collective knowledge in this manner are still too few in Japan.

Multistakeholder-developed, broad-based policy proposals are more impactful and useful than policy proposals that represent the views of only one specific industry or stakeholder. We believe that it is our commitment to the development of such proposals that has allowed us to influence policy reforms up to this point.

Based on that belief, we have focused our activities in recent years around a singular policy: "HGPI is dedicated to fostering multi-stakeholder health policy debate globally, with a commitment to the inclusion of civil society. Through conversations with stakeholders, HGPI is working to realize evidence-based health policies that are meaningful in a global context, and of real value to the people that need them the most."

What is the best way to gather diverse opinions and synthesize collective knowledge? We want to create evidence-based policy proposals, but how should we define "evidence" in our recommendations, when health policy so often focuses on such broad topics as the way people live, their happiness, and their health? Policy creation and validation sometimes requires us to redefine existing values and methods. This requirement should not be taken lightly. We believe that we must approach the development of health policy seriously, with an understanding of the true impact that policy can have on people's lives. I believe that our serious approach to these issues is what makes it possible for us to consistently gather diverse stakeholders from all sectors for open and free debate on various policies.

Every one of the core members of HGPI is committed to pursuing the creation of a better world. We are dedicated to developing the policy options that society needs through careful and deliberate debate. We humbly request your continued support for these efforts.



UN General Assembly High-Level Meeting on AMR Side Event

Global Action on AMR: Advancing Healthy Longevity and Sustainability under UHC

HGPI and AMR Alliance Japan hosted a side event on the 25th of September in conjunction with the 79th UN General Assembly High-Level Meeting on Antimicrobial Resistance (AMR) in New York City. The event brought together a panel of experts from government, industry, academia, and civil society including AMR survivors. In commemoration of this side event, Prime Minister of Japan, Fumio Kishida sent a prerecorded video message and Dame Sally Davies UK Government Special Envoy on Antimicrobial Resistance sent a pre-written message.





Japanese Version Release

Call for Actionable Steps in Response to the Rising Threat of Antimicrobial Resistance (AMR)

JUL 03, 2024

HGPI and AMR Alliance Japan published Japanese translations of the "Call for Actionable Steps in Response to the Rising Threat of Antimicrobial Resistance (AMR)". The recommendations were developed by the AMR Multi-Stakeholder Partnership Platform ahead of the United Nations High-Level Meeting on AMR set to be held in September 2024.



AMR Alliance Japan

Established in November 2018 by academic societies working in infectious disease medicine, pharmaceutical companies, and medical device manufacturers, AMR Alliance Japan is an independent platform for the promotion of multisector discussion on AMR countermeasures. The Alliance develops and disseminates policy recommendations to: (1) ensure that AMR countermeasures are in line with the current situation of patients and healthcare settings; (2) promote the national and international AMR agenda; and (3) advance Japan's AMR policy.

Policy Recommendations

Establishing a System That Makes Full Use of Primary Care Physicians and Can Respond to Complex Chronic Pain

HGPI Chronic Pain Project views primary care physicians as key players for timely and appropriate interventions to pain and offer policy recommendations to the current discussion at the Ministery of Health, Labour and Welfare on system reforms for primary care physicians.

- 1 Primary care physician services should be strengthened so primary care physicians can stay close to patients' pain regardless of its mechanism or complexity and serve as the gateway to healthcare while providing appropriate treatment and referrals to specialists.
- While taking into account the latest findings in pain science and how chronic pain is classified in the International Classification of Diseases, steps should be taken to develop reporting items related to primary care physician services as well as programs that provide primary care physicians with training and recurrent education.
- A collaborative system that links primary care physicians and a wide range of community resources including pain centers should be established so people can receive a wide range of evidence-based interventions in their communities and, when necessary, have rapid access to multidisciplinary pain care.
- 4 Ample consideration should be given to the perspectives of pain science experts and healthcare beneficiaries during discussions on the functions of primary care physicians held at Regional Consultation Forums on Ambulatory Care.

Kidney Disease Control Promotion Project

AUG 28, 2024 Public Symposium

Establishing Kidney Disease Control Measures with Patient, Citizen, and Community Engagement and Collaboration

It brought together a wide range of stakeholders including governmental bodies (both central and local), legislators, academics, healthcare professionals, and patients/citizens involved in kidney disease management nationwide. The symposium aims to promote collaboration towards the realization of the next steps in patient- and citizen-led CKD strategies.





NCD Alliance Japan

NCD Alliance Japan is a collaborative platform for civil society organizations in the NCD community steered by the Health and Global Policy Institute. Its aim is to further promote comprehensive, cross-cutting NCD policies.

Dementia Policy for an Inclusive Society 2024: HGPI Recommendations on The Basic Plan on Dementia to Promote an Inclusive Society (Draft) and Basic Measures (Draft)

In August 2024, the division of Dementia Policy and Community-Based Long-Term Care Promotion, Health and Welfare Bureau for the Elderly, Ministry of Health, Labor and Welfare conducted a "Call for Public Comments on The Basic Plan on Dementia to Promote an Inclusive Society (Draft) and Basic Measures (Draft)." The HGPI Dementia Project has submitted its opinions in response to this call for public comments, and has prepared policy recommendations based on these opinions. The intent of these recommendations is to inform society of the content of the HGPI Dementia Project's response to that call for public comments to provide society with policy options in the discussion on the Basic Plan for the Promotion of Policies on Dementia, which will soon come to a close, as well as in discussions on future versions of the Basic Plan.



The Resolution on Social Participation at the 77th World Health Assembly



Resolution WHA77.2 "Social participation for universal health coverage, health and well-being" was endorsed by the 77th World Health Assembly in May 2024. According to the World Health Organization (WHO), "social participation" is defined as, "Empowering people, communities, and civil society through inclusive participation in decision-making processes that affect health across the policy cycle and at all levels of the system." As this resolution is likely to result in social participation becoming an increasingly important factor in the health policy formulation process, this column will examine the history of events that led to the resolution as well as its content.

HPA: Health Policy Academy

The 13th Session "Citizenship and Health Policy"



At the 13th HPA, participants will spend approximately six months exploring how to engage with health policy as citizens. The curriculum is structured in stages, from the basics of policy, through theory and analysis, to practical application. Each lecture will feature instructors who are currently active in their respective fields, and participants from diverse backgrounds will engage in discussion. Through group work aimed at creating policy proposals that serve as the final assignment, the program aims to equip participants with the mindset necessary for the actual policy-making process.

Global Health



Global Health Education Program (G-HEP)

The "Global Health Education Program (G-HEP)" vision is to establish a global community of young leaders that can work together to push global health agendas forward and to conduct human resources training and development for the future. The partnership with the Mahidol University Faculty of Public Health which began in 2018 extended the program's boundaries through interactions among young generations not only from Japan but from the ASEAN region as well. Fieldwork in Bang Krachao, Thailand

G-HEP conducted a week-long fieldwork activity in Bang Kachao, Thailand from August 5th to August 9th. Twelve participants of the G-HEP coming from the United States, Thailand, and Japan all met up in Thailand for a week of fieldwork activities.



We visited a plastics recycling center located on the grounds of the Wat Chak Daeng temple.

The participants met with local community workers who, through interpreters, were able to ask questions and learn more about their target population for the case studies




Survey of Japanese Nursing Professionals Regarding Climate Change and Health

HGPI and the Graduate School of Health Sciences, Niigata University conducted an online self-administered questionnaire survey of nursing professionals in Japan to gather opinions on climate change and health, sustainable health systems, and climate change policies. This preliminary report provides a summary of key opinions and findings on the challenges, feasibility, and educational needs for integrating climate change into nursing education and practice in Japan. In addition, this preliminary report aims to propose in response to public comment on the Model Core Curriculum for Nursing Education (Draft Revised Version for FY2024) by the Ministry of Education, Culture, Sports, Science and Technology.

Four Key Findings

1. 72% of the responses indicated that climate change is an important issue for nursing professionals




The top reasons for why climate change is an important issue included opinions such as "it is related to life and has a strong connection to the field of healthcare," "it is necessary to address it for the sake of future generations," and "the field of healthcare also has a negative impact on the environment."

2. 80% of the responses indicated that they believe it is necessary for nursing professionals to learn about "climate change and health"

The main reasons for the need to learn included opinions such as "it is a life issue that nurses need to be aware of," "we need to better understand the negative impact of healthcare on the environment," and "we believe it is necessary to take action in the future for the sake of the patients we care for and future generations."

3. 84% of the responses by the nursing professionals indicated a willingness to learn about "climate change and health."



The top topics they would like to learn about included topics such as "the impact on health and related diseases," "preparedness for emergencies such as extreme weather events," and "practical methods for applying this knowledge in daily work."

4. 69% of the respondents reported that outside of work, they provide health or medical information, advice, or support to those close to them, such as family, friends, and neighbors.

Connecting Climate Minds is a global initiative funded by Wellcome, that brings together expertise across research, policy, design, and lived experience from across the globe. The aim of the project is to develop a research and action agenda of global and regional community convenors dedicated to connecting climate change and mental health. HGPI was invited to participate as a Regional Co-Convenor (RCC) for the Eastern and South-Fastern region in the Connecting Climate Minds project. In this year-long project.

In this year-long project, 900 participants across diverse disciplines from more than 90 countries, representing 7 regional communities, came together to connect, learn, and understand ways in which to better accelerate global efforts to address the current challenges at the intersection of climate change and mental health.

Policy proposal for Promotion of Menopausal Women's Health as a Social Issue to be Considered by Industry, Government, Academia and the Private Sector

In recent years, policies aimed at promoting women's health across the life course have been advancing. However, societal awareness and understanding of menopausal health issues remain insufficient, posing significant challenges for working women. In 2023, HGPI launched the "Policy proposal for Promotion of Menopausal Women's Health as a Social Issue to be Considered by Industry, Government, Academia and the Private Sector" project. This project involved qualitative surveys, company surveys, advisory board meetings, and an international symposium. Based on these efforts, HGPI formulated policy recommendations to aid policymakers and stakeholders in advancing menopausal health measures in Japan.

9 Policy Recommendations

- 1 National and local administrative bodies should clarify measures for menopause, and establish the necessary systems and budgetary measures for their implementation.
- 4 While expanding the counseling system, which is the key to menopause care, national and local authorities should provide suitable financial support to implement counseling resources.
- **7** Promote awareness among young people in communities and during school education to improve access to appropriate care for menopausal symptoms and disorder and to elevate wellbeing from menopause to old age.

- **2** Establish command centers for menopause measures in each region to serve as focal points for promoting menopause measures that are suited to local conditions and the needs of affected community members.
- Hot flashes, dizziness, irregular heartbeat, headache, anxiety, depression, and general malaise are the main symptoms of menopause and should be included in the Model Core Curriculum for Medical Education as items for the differential diagnosis of menopausal disorder.
- **8** Businesses should engage in organization-wide initiatives to ascertain circumstances within their organizations and to create workplace environments in which affected parties can speak up.

- 3 Improve access to menopause care so people living with menopausal symptoms or disorder can access the right care at the right times. Furthermore, engage related parties in considering how to facilitate and improve collaboration among medical departments that are related to menopause care.
- 6 Create various opportunities for physicians that are involved in menopause care to learn about menopause, such as during the processes for acquiring or maintaining specialist certifications.
- 9 While collaborating with industrial physicians, occupational health nurses, and outside lecturers, businesses should conduct training seminars or study sessions for all employees, deepen understanding toward affected parties among management, and strengthen organization-wide initiatives.

The Ideal System for Perinatal Medical Care in Japan in the Era of Declining Birth Rates

In 2023, the number of births in Japan was approximately 750,000, continuing to hit record lows since records began. Addressing the urgent issue of halting the declining birth rate is critical. Amid various measures being promoted by the government, discussions are set to begin around 2026 regarding the insurance coverage of childbirth expenses.



Moreover, while there are calls to reduce the burden of childbirth costs, the management environment surrounding obstetric medical institutions has become increasingly challenging due to the decrease in the number of births and rising prices. There is concern that sudden systemic changes could destabilize the safe and secure perinatal medical care system.

HGPI composes and publishes reports and policy proposals for each of its projects.
